



Gerald Kohers, chair of the Committee on Committees, handed out proposed nominations to university committees for those positions which are either directly appointed by the Senate or recommended by the Senate for appointment to serve. There followed some discussion as to whether or not the Senate should appoint faculty to the Women's Advisory Committee which has been defunct (or inactive) for at least five years. There followed a general discussion as to whether or not to nominate faculty to any committee that is known to have never met. It was determined not to appoint new committee members to defunct committees with the proviso, that if there was a request for a committee to be appointed, it would be done.
