Ourricular PracticalTraining (CPT) is defined by federal regulations as "an integral part of an established curriculum" related to your program of study. This can be in the form of an internship, practicum, or in the case of graduate and doctoral studenthesis and dissertation ourses taken for course credit.

Part-Time CP (Employment for 20 hours or less per week white ingenrolled full-time in classes)
